

# VCH Region Application Form: Addiction Care and Treatment Online Course (ACTOC)



## Information for Applicant

The Vancouver Coastal Health Regional Addiction Program (VCH RAP), Toxic Drug Response (TDR) team and BC Centre on Substance Use (BCCSU) are committed to building capacity amongst care providers to support patients who use substances.

VCH RAP is currently funding select care providers for their time in completing the Addiction Care and Treatment Online Course (ACTOC). ACTOC is a free online MOC Section 3 and MainPro+ accredited course developed by the BCCSU targeted at health care providers interested in learning more about substance use and caring for people experiencing substance use disorders, including alcohol, tobacco, stimulants, cannabis, and opioid use disorder.

**Who?** If you are an MD, NP, Resident, RN, LPN, RPN, Pharmacist or Allied Health Professional interested in expanding your substance use knowledge, you could be approved for funding. In order for your application for funding to be considered, you must be practicing/working within the VCH region in some capacity that supports people who use substances.

**What?** The ACTOC training is 16-20 hours of self-paced learning. If you are funded for training it is expected that you complete training within 3 months following invite/offer. Funding is not provided retroactively. It is only available to people who have not yet completed the course.

**How?** Complete this application and submit it to be [eatnetwork@vch.ca](mailto:eatnetwork@vch.ca) for review. Funding opportunities are limited but applicants selected will receive funding to compensate them for time spent completing ACTOC.

**When?** There is no deadline to apply. Applications are accepted and reviewed on a rolling basis.
